We pay tuition, room, and board at secondary school and university for our students and others who perform well from local schools. We have built two health clinics that serve over 20,000 patients annually. In addition to our education and health programs, we support families and the local village by creating jobs at the school and the clinics and by creating a school farm that introduces modern farming techniques.
